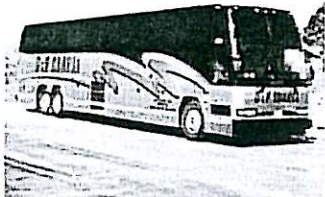

Auto Tech Field Trip to Summit Raceway Park in Norwalk Ohio

The Auto Tech Lab is planning a field trip on Friday May 21, 2010 to the drag races at Summit Raceway Park in Norwalk Ohio. We will leave the Erie County Technical School (ECTS) at 12:30 pm. and return to ECTS at 3:30 am. Transportation will be by coach bus. We will arrive at Summit Raceway Park at 4:30 pm. with qualifying time trials starting at 5:00pm. The elimination rounds start at 8:00 pm, and should end by 11:30pm. We will leave the races by 12:00 midnight and return to ECTS by 3:30 am. Students that do not drive must be picked up at ECTS by 3:30am in the front school parking lot.
