We want to participate in Energy Curtailment Specialists (ECS)' "PowerPay!" Flex-Response Program designed for the PENELEC service territory. By signing this form we understand the following:

- (1.) We authorize ECS to register us with PJM as an Economic and Emergency (DR) resource and with PENELEC and complete any forms as necessary in order to qualify for this program;
- (2.) PENELEC is in need of demand reductions from customers during projected peak demand hours from June through September each year. The PENELEC program is available for the 2012-13 delivery year and MAY be available in subsequent delivery years. ECS will register us in all available delivery years. The event calls will occur on weekdays only, most likely between the hours of 12:00 pm and 7:00 pm. We will receive a day-ahead warning, with an approximate 3 hour in-day advance notice confirming or modifying the event hours.
- (3.) We will be notified by ECS of up to 75 potential reduction hours. We have the flexibility to reduce in any number of those hours (i.e. all 75, 50, 30, etc) and can reduce as much or as little electricity in any given reduction hour throughout the reduction period, up to our total expected reduction over the summer period. We will receive a day-ahead warning, with an approximate 3 hour in-day advance notice confirming or modifying the PENELEC event hours. Our participation is governed by the rules of the PENELEC program.
- (4.) **Payments and Bonus for 2012: We will receive \$350 per MWh (per MW per hour) for all energy reduced during called events, up to our total expected reduction over the summer period. ECS will determine our expected reduction in their discretion based upon their assessment of our ability to perform. We will also receive a signing bonus of \$1,000 per MW within 30 days of our successful registration.**
- (5.) **Payments for Subsequent Years:** Payments will be established if and when PENELEC establishes the program for subsequent years (ECS will notify us of the payment rate once the program is established). Payment will be based on the performed kWh/MWh up to our expected kW/MW reduction.
- (6.) **We will not be subject to out-of-pocket financial penalties by participating in this program, even if we fail to reduce electricity when called upon.**
- (7.) **If necessary, ECS will install an interval meter at no cost to us.** In fact, we will never be responsible for any cost as a result of our participation in the program.
- (8.) We agree to participate for the next five (5) complete obligation periods. Our participation will be governed by the rules of the PENELEC and PJM programs.

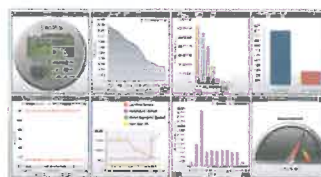

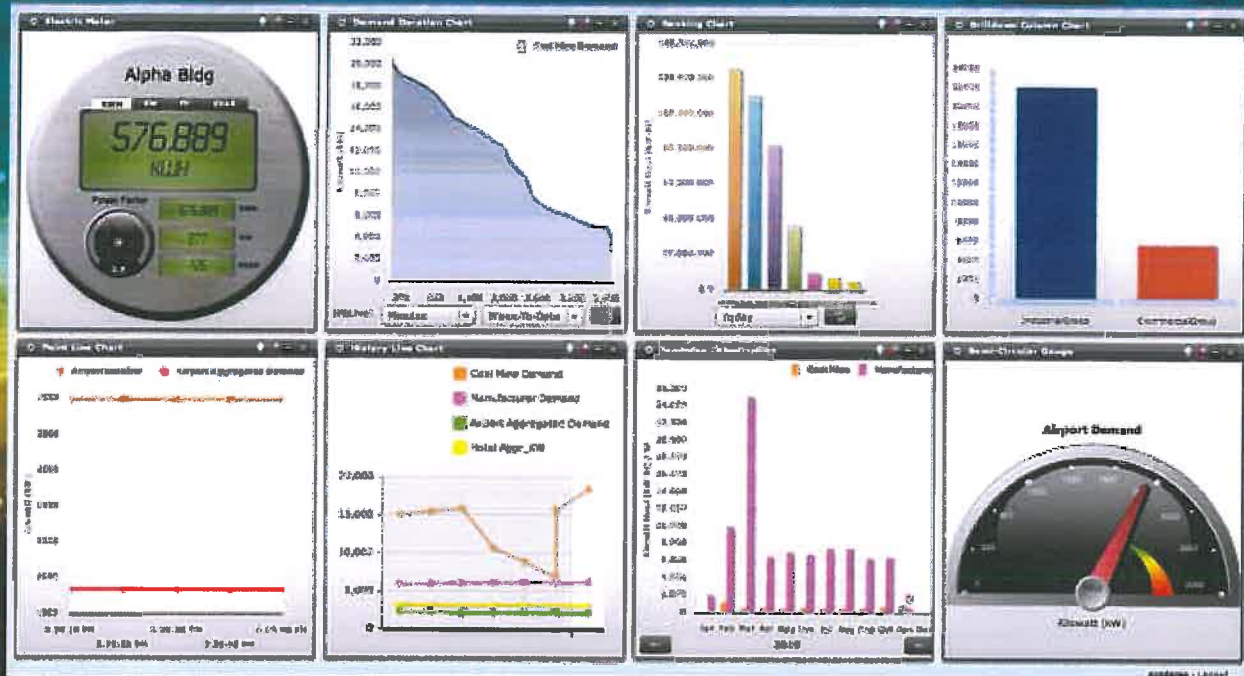
