A bid tabulation for the above project is enclosed. Several bids were received for each trade excluding the General Contractor, who was the only contractor to attend the Mandatory Pre-Bid. The HVAC and Electrical bids were competitive but over our estimated total cost. The project was more complex from an engineering standpoint than we originally thought.

We feel the lowest bids are from local responsible contractors that we have had on previous projects and recommend that you award contracts to them as follows:

General Construction:	Considine Biebel & Company	\$ 84,900.00
HVAC Construction:	Scobell Company, Inc.	118,470.00
Electrical Construction:	Church & Murdock Electric, Inc.	<u>4,115.00</u>

For a total award of **\$207,485.00**

Should the Board concur with this recommendation, we will ask the contractors to submit the required bonds and insurance certificates and we will prepare AIA Construction Contracts and Mechanic's Lien Waivers for this project.
