Motion to approve an initial design price point not to exceed \$32,500,000

Without a maximum price point for the initial design work being established, it will difficult to ensure that the plans and drawings will fall within an acceptable price range. Dr. Walker discussed that a price point not to exceed \$32,500,000 should be considered. This price point of \$32,500,000 is not a commitment to a final number, but will be used as an initial design maximum price point. Mr. DiPlacido noted he prefers a lower price point of \$25,000,000.

Mr. Bucksbee recommended the formation of a sub-committee consisting of 3 – 5 JOC members for the project to try to streamline the process once the project begins.

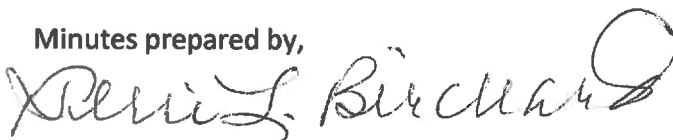
