**Presentation and Discussion Regarding Career Street Program
Rick Scaletta, General McLane School District Superintendent**

Rick Scaletta, Superintendent of the General McLane School District, discussed alternatives to move the Career Street Program from the ECVTS Foundation to another Erie-area non-profit organization. This transition of the program from the ECVTS Foundation to the Erie County Career Pathways Alliance could occur at the end of this fiscal year with an effective date of July 1, 2019. Additionally, there is potentially a \$50,000 grant available that could be applied for once the Career Street program and its new non-profit entity combine activities into one non-profit.

Certain agreements, such as the intellectual property rights for Career Street and the new website, would be negotiated prior to the transfer of Career Street. Mr. Scaletta explained that the area’s Superintendents continue to rely on Career Street activities for their students and that the Districts have agreed to allow portions of their annual reimbursable funds to be allocated to Career Street general operations until the transition can occur at the end of this fiscal year.

Mr. Scaletta requested the Foundation’s consideration in a transition from the ECVTS Foundation to the Erie County Career Pathways Alliance.
